Bidders, submitting their bid electronically, should deposit the cost of bidding document NRs. 3,000.00 of bidding document in the following Rajaswa (revenue) account as specified below:

4. Electronic bids must be submitted to the office Nepal Police Headquartes, Cyber Bureau Bhotahiti, Kathmandu, Nepal. through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 noon on 10 Oct 2021 (24-06-2078)** Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 noon on 10 Oct 2021 (24-06-2078)** at the office of Nepal Police Headquartes, Cyber Bureau Bhotahiti, Kathmandu, Nepal. Bids must be valid for a period of 60 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **1,60,000.00** which shall be valid for 30 days beyond the validity period of the bid (i.e. **07 Jan 2022**)
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
7. **Police Headquarters Cyber Bureau, Bhotahiti, Kathmandu** reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason whatsoever.
8. The bidder who has been punished for a profession or business related offenses, black listed company, Firm, person and a company fully or partially owned by black listed company are not eligible to bid.
